# TOTAL BID PRICE / BASE BID

For the furnishing of the labor, materials, and equipment necessary to complete all work designated in the Plans and Specifications.

#### **INSURANCE**

#### **BONDS**

If a Contract is terminated according to this provision, the District is entitled to pursue any available legal remedies.
