

In compliance with your invitation for bids, the undersigned has carefully examined the project Bid Documents, including the drawings and specifications, for the scope of work which is to construct a new storage building structure for the specific purpose and use as a storage facility for reserve apparatus equipment in the City of Hesperia, California and fully understands the scope and meaning of the Bid Documents.

The undersigned hereby agrees to furnish all materials, labor, tools, equipment, apparatus, facilities, and transportation necessary to complete all work in strict conformity with the drawings and specifications, and to execute the contract to the satisfaction of the Project and Facilities Management Department, at the following cost(s):

In case of discrepancy between the written bid set forth and the numerical bid set forth, the written bid shall prevail. In the case of a discrepancy between the written bid or numerical bid set forth on the bid proposal, and the numerical bid set forth in the ePro system, the information on the bid proposal shall prevail.

#### BASE BID

For the furnishing of the labor, materials, and equipment necessary to complete all work designated in the Plans and Specifications.

The above-mentioned BASE BID includes applicable California state sales tax, bonds, insurance, and all other costs required to perform all the work described in the project drawings and specifications.

The lowest bid shall be the lowest bid price on the BASE BID. A responsible and responsive bidder who submitted the lowest bid shall be awarded the contract if it is awarded.

#### BID DEPOSIT (BID BOND)

There is enclosed herewith, a certified check or surety bond in the amount of ten percent (10%) of the BASE BID, or, more specifically, One Hundred Seventy Six Thousand

Dollars (\$176,000 ), made payable to San Bernardino County. The undersigned agrees that in the event of the failure by the undersigned to execute the necessary contract and furnish the required contract bonds and insurance, the certified check or surety bond and the money payable thereon shall be, and remain, the property of the District. If the bid is accompanied by a certified or cashier's check, the check shall be deposited by the Project and Facilities Management Department, and a County warrant for the full amount shall be issued to the undersigned approximately one month after Contract Award.

If the bid is submitted through the San Bernardino County Electronic Procurement Network (ePro) then scan the bid security (bid bond) and submit the scanned copy with your bid submittal in ePro, additionally, mail or submit the original bid security, in a separate sealed envelope labeled "Bid Bond" with the title of the work and the name of the bidder clearly marked on the outside, to: Project and Facilities Management Department, 385 North Arrowhead Avenue, 3rd Floor, San Bernardino, California, 92415-0184. Any mailed or submitted bid security must be received on or before the time set for the opening of the bids.

#### TIME OF COMPLETION

The undersigned agrees to complete the work within **270** calendar days from the date stipulated in the Notice to Proceed.

#### LIQUIDATED DAMAGES

Pursuant to the provisions of Government Code Section 53069.85 and in the event that all the Work called for in this Contract is not completed within the number of calendar days set forth, Contractor shall forfeit and pay to the District the sum of \$500.00 per day for each calendar day the work remains incomplete, to be deducted from any payments due or to become due to the Contractor. (Reference General Conditions and Special Conditions)

#### **ESCROW ACCOUNT**

Pursuant to Section 22300 of the Public Contract Code, at the request and expense of the Contractor, the Contractor may substitute qualified securities in lieu of retention withheld by the District and/or establish an escrow account for retention payments.

#### REJECTION OF BIDS

The undersigned agrees that the District reserves the right to reject any or all bids, and reserves the right to waive informalities in a bid or bids, not affected by law, if to do so seems to best serve the public interest.

#### VALIDITY OF BIDS

The undersigned agrees that this bid will remain valid for sixty (60) days after the scheduled bid opening.

#### STATE LICENSES

The undersigned hereby certifies that he is currently the holder of a valid State Contractor's Class "B" license as a contractor in the State of California and that the license is the correct class of license for the work described in the project drawings and specifications. The undersigned also certifies that all subcontractor(s) listed under the Designation of Subcontractors section of the Bid Proposal are currently the holder of valid contractor's license(s) in the State of California and the license is the correct class of license for the work to be performed by the subcontractor(s).

#### INSURANCE

The undersigned agrees to furnish certified copies of all insurance policies and endorsements; all certificates of comprehensive, general and auto liability insurance; Workers' Compensation insurance; and such other insurance that will protect him from claims for damages and personal injury, including death, which may arise from operations under the contract, whether such operation be by the undersigned or by any subcontractor of the undersigned, or anyone directly or indirectly employed by the undersigned or any subcontractor of the undersigned in accordance with Section 11.2 of the General Conditions. The undersigned agrees to provide the Project and Facilities Management Department with Certificates of Insurance evidencing the required insurance coverage at the time Contractor executes the contract with the District. All policies (excluding Workers' Compensation) shall name San Bernardino County, the District, and their officers, employees, agents, and volunteers as additional insureds. All coverage shall be subject to approval by the District for adequacy of protection.

#### **BONDS**

If this Bid is successful, the undersigned agrees to execute the required Standard Contract and will furnish a payment bond in an amount equal to one hundred percent (100%) of the contract price and a Faithful Performance Bond in an amount equal to one hundred percent (100%) of the contract price. These bonds shall be secured from a surety company or companies satisfactory to the District within ten (10) calendar days of the contract award and shall be on District approved bond forms. Bonds shall remain in full force and effect for a period of one year following the date of filing of the Notice of Completion.

#### FORMER COUNTY OFFICIALS

Contractor agrees to provide or has already provided information on former San Bernardino County administrative officials (as defined below) who are employed by or represent Contractor. The information provided includes a list of former county administrative officials who terminated county employment within the last five years and who are now officers, principals, partners, associates, or members of the business. The information also includes the employment with or representation of contractor. For purposes of this provision, "county administrative official" is defined as a member of the Board of Supervisors or such officer's staff, Chief Executive Officer or member of such officer's staff, county department or group head, assistant department or group head, or any employee in the Exempt Group, Management Unit or Safety Management Unit.

#### INACCURACIES OR MISREPRESENTATIONS

If during the course of the bid proposal process or in the administration of a resulting Contract, the District determines that the contractor has made a material misstatement or misrepresentation or that materially inaccurate information has been provided to the District, the contractor may be terminated from the bid proposal process, or in the event a Contract has been awarded, the Contract may be immediately terminated. If a Contract is terminated according to this provision, the District is entitled to pursue any available legal remedies.

#### **VISITING THE SITES**

The undersigned has visited the site and is familiar with the local conditions of the work site.

### CALIFORNIA AIR RESOURCES BOARD (CARB) IN-USE OFF-ROAD DIESEL-FUELED FLEETS REGULATION COMPLIANCE CERTIFICATION

This Project is subject to the California Air Resources Board (CARB) approved amendments relating to In-Use Off Road Diesel-Fueled Fleets found at California Code of Regulations Title 13, sections 2449, 2449.1, and 2449.2 (the "Regulations"). The Regulations require a Prime Contractor, bidding on a public works project to be awarded by any public works awarding body, to certify that the Contractors off-road diesel-fueled fleets comply with CARB regulations. Section 2249(b) includes a list of

off-road diesel-fueled fleets subject to these regulations. It is the responsibility of the Contractor to verify if their fleet is subject to these regulations.

Contractor is required to obtain and submit Certificates of Reported Compliance from all subcontractors that are listed in the bid submission. Failure to provide Contractor's CARB compliance number may constitute a material irregularity rendering their bid non-responsive and non-responsible, and subject to rejection for non-responsiveness.

No award shall be made to a Contractor that has failed to provide its CARB compliance certificates, unless the Contractor confirms that no equipment subject to the regulation will be used to execute the Contract Work. By submitting a bid, the Bidder hereby certifies that it is aware of the requirements set forth in Sections 2449, 2449.1, and 2449.2, Title 13, California Code of Regulations and any successful Bidder and its subcontractors shall comply with sections 2449, 2449.1, 2449.2 of Title 13 of the California Code of Regulations, including by providing Certificate(s) of Reported Compliance for In-Use Off-Road Diesel-Fueled Fleets for the fleet selected for the contract and their listed subcontractors, if applicable, with its bid.

Contractor shall not enter into a contract with a fleet for which it does not have a valid Certificate of Reported Compliance for the fleet and Contractor's listed subcontractors, if applicable, prior to entering into a new or renewed contract with that fleet. Contractor shall only allow fleets with valid Certificates of Reported Compliance on Contractor's job sites. The Certificates of Reported Compliance received by the Contractor for this Project must be retained for three (3) years after the Project's completion. Upon request by CARB, these records must be provided to CARB within five (5) business days of the request. Between March 1 and June 1 of each year, Contractor must collect new valid Certificates of Reported Compliance for the current compliance year, as defined in Regulation Section 2449(n), from all fleets that have an ongoing contract with the Contractor as of March 1 of that year. Contractor must not write contracts to evade this requirement.

If Contractor discovers that any fleet intending to operate vehicles subject to the Regulation for Contractor does not have a valid Certificate of Reported Compliance, as defined in Regulation section 2449(n), or if Contractor observes any noncompliant vehicles subject to the Regulation on Contractor's job site, then Contractor must report the required information to CARB within the time period contained in in the Regulations.

Upon request by CARB, Contractor must immediately disclose to CARB the name and contact information of each responsible party for all vehicles subject to the Regulation operating at the job site or for Contractor. If applicable, Contractor shall prominently display signage for any project where vehicles subject to the Regulation as provided and within the time period contained in the Regulation.

Situations in which prime contractors or public works awarding bodies, as applicable, are contracting for projects that are considered emergency operations, as defined in

section 2449(c)(18), are exempt from the requirements in section 2449(i)(1)-(3), but must still retain records verifying vehicles subject to the regulation that are operating on the emergency operations project are actually being operated on the project for emergency operations only. These records must include a description of the emergency, the address or a description of the specific location of the emergency, the dates on which the emergency operations were performed, and an attestation by the fleet that the vehicles are operated on the project for emergency operations only.

Contractor shall complete and return the "California Air Resources Board (CARB) In-Use Off-Road Diesel-Fueled Fleets Certification of Compliance" form attached hereto as a condition to bidding this Project.

#### **DESIGNATION OF SUBCONTRACTORS**

In compliance with the provisions of Sections 4100-4108 of the Public Contract Code of the State of California, and any amendments thereof, the undersigned shall set forth below the name, location of the place of business and the California contractor license number of each subcontractor who will perform work (meaning the total amount of the subcontractor's contract amount including all labor, materials, supplies and services) in excess of one-half of one percent (1/2 of 1%) of the total bid; and, the general category or the portion of the work to be performed by each subcontractor.

If the undersigned fails to specify a subcontractor for any work to be performed under the contract, the undersigned agrees to perform the work and shall not be permitted to subcontract that work except in cases of public emergency, and then only after written finding as public record by the Board of Supervisors.

The undersigned certifies that all subcontractor(s) listed below are currently the holder of valid contractor's license(s) in the State of California and the license(s) is the correct class of license for the work to be performed by the subcontractor(s).

The undersigned certifies that it <u>and</u> all subcontractor(s) listed below have registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 (applicable for all bids submitted on or after March 1, 2015). The undersigned agrees that no contractor or subcontractor may be awarded a contract for public work or perform work on a public works project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 (applicable for all contracts awarded on or after April 1, 2015). The undersigned acknowledges that the project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

As required by Labor Code 1771.1(a) "A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work

It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded."

#### **Revision to Bid Documents:**

Subcontractors listed by the bidder shall possess, both at the time of the award of a contract to the bidder and at all times when work is performed, a valid contractor's license for the appropriate classification necessary to perform the work for which that subcontractor is listed. Failure of the bidder to deliver evidence to the County prior to the award of a contract for this Project that each and every subcontractor listed by the bidder is properly licensed for the classification necessary to perform the work for which that subcontractor is listed, shall constitute a failure to execute the contract and may subject the bidder to all legal penalties imposed by law, including, but not limited to, forfeiture of the award of contract for the Project.

#### Responses to Bidder's Questions:

Question #1 - Project name is Butler Building acquisition project. We are able to furnish and install Butler Buildings. Plan references Nu-Cor Building purchased by FCP. Please confirm we can furnish and install a Butler building or is the Nu-Cor building already purchased by FCP?

**Reply** – An equal substitution will be considered. See Specification Section 01 6000 PRODUCT REQUIREMENTS 1.06 SUBSTITUTIONS.

Question #2 – The Bioretention Facility shown on C-2 & WQMP-1 calls for Engineered Soil Media per Table A-1. Table A-1 does not appear on either of these sheets. Where would we find Table A-1?

Reply – Please incorporate the following table in the WQMP plan Sheet WQMP-1 and C-2.

**Table 1: Mineral Component Range Requirements** 

Percent Range	Component
70-80	Sand
15-20	Silt
5-10	Clay

**Question #3** - The Bioretention Facility shown on C-2 & WQMP-1 indicates masonry walls but calls out a spec for Caltrans Type B3-1A walls. This spec is for tapered cast-in-place concrete walls. Very expensive. Is this really what you want to use in this application? How about County Std Drawing 301a?

**Reply** - Replace the Caltrans retaining wall called for on the plans, Detail 2/C-2, with a SPPWC (Greenbook) Standard 610-3, H=6'. All other requirements shall remain as shown on Detail 2C-2.

Question #4 — The Bioretention Facility shown on C-2 & WQMP-1 calls for root barrier on the concrete walls. Is there a waterproofing system under this root barrier?

**Reply** - The root barrier is a waterproof membrane designed to prevent water infiltration.

**Question #5** - The Pump Station on WQMP-1 indicates that the effluent pipe extends to daylight. Is there an outflow structure or pop-up at the end of this effluent pipe?

**Reply** - Extend the 3-inch discharge line from the pump station to the flowline of the adjacent ditch. Install a Jensen Precast, or approved equal, "Drop Inlet – 1212 x 24 in – Cast in frame" with non-traffic rated grate on the discharge end of the 3-inch outlet pipe. Install 6-inch cobble, 5' by 5', around the drop inlet. Rock shall extend a minimum of 12-inch below existing grade.

**Question #6** – Neither C-1 nor A1.1 indicate the location of any construction, expansion or weakened plane joints in the concrete paving. What is the intended spacing on these joints?

**Reply** – See Sheet A1.1 Note #13 for information about driveway expansion and control joints. See Sheet A2.1 Note #7 for control joint locations (CJ).

Question #7 – Electrical sheet E1.1 indicates new conduits mounted on the existing perimeter wall. Do these conduits get painted?

**Reply** – GC shall include paint for these conduits to match as much as reasonably possible the surrounding color.

Question #8 - There are no structural drawings, and the Nucor drawing do not indicate a foundation design. Is it the County's intent that the GC retain a structural engineer on a design/build basis to provide foundation and SOG structural design as part of this contract?

**Reply** – The GC is responsible for design/build the entire foundation system based on the loads given by the GC's metal building manufacturer. See T1.1 NOTES TO GENERAL CONTRACTOR and note on sheet A4.0, A4.1, and A4.2.

**Question #9** - Is the county providing the prefabricated metal building or does the GC need to purchase it?

Reply - The GC must purchase and erect the prefabricated metal building.

**Question #10** - Specification Section 05 5000, 3.05 C-H state several steel items as scheduled but the extents and locations of those items are not shown on the plans. Please clarify.

Reply - Section 05 5000, 3.05 C-H items are not applicable to this project and may be omitted.

**Question #11** - Specifications section 08 3323, 2.02, A2 states capable of withstanding 20 PSF wind loads. Spec section 13 3419, 1.5, C5a and b states building wind speed 120 MPH and wind exposure C. Will the 20 PSF door be sufficient or will a greater PSF be required?

**Reply** – The Overhead Coiling Doors shall be designed to withstand wind loads imposed upon the specific site where they are being installed. This may include a special wind study zone that applies to this project. Please omit specification Section 08 3323 2.02 A2 in its entirety. Revise "Design Wind Speed" from 107 MPH to 120 MPH in Specification Section 08 3323 1.05 DESIGN REQUIREMENTS A1.

**Question #12** - Specification section 13 3419, 2.1B states manufacturer substitutions can be found in section 01 6000 - PRODUCT REQUIREMENTS. Please provide this spec section.

**Reply** – That is a typo, see Specification Section 01 6000 PRODUCT REQUIREMENTS 1.06 SUBSTITUTIONS.

**Question #13** - Specification section 26 0010, 1.03A states CAD format must be submitted as record drawings. Please clarify, is this a requirement for electrical only or for the entire project.

**Reply** – The requirement is for electrical only but can be submitted on paper with neatly drafted red lines by hand.

Question #14 - There is a discrepancy as to POC for Domestic Water on two plans - WQMP 1 Plan shoes POC in the northern part of the site while C-1 shows the domestic POC on the south of the site. Please clarify which location to follow.

**Reply** - Follow the location shown on C-1 as this location avoids having to sawcut and patch the existing fire station driveway.

Question #15 - The form "Contractor Certification (CARB)" states if CARB vehicles are used then the Valid Certificate of compliance must be submitted. Is this a bid requirement for contractor and all sub-contractors at bid time or award? We can list certificate numbers for qualified subs on the sub-contractor list for bid purposes and provide each certificate if awarded.

**Reply** — Contractor Certification (CARB) is a bid requirement that is required for the Contractor and any listed Sub-Contractors.

Question #16 - Regarding Site Concrete paving: Geotechnical report recommends doweled joints at 15' OC max each way with no expansion joint filler while implying the joints to be sawcut. Architectural detail 4/A1.1 indicates a formed construction joint with expansion joint filler and caulking. Please clarify if concrete should be placed in checkerboard with bulkheads at 15' OCEW or a monolithic pour with embedded dowel racks under a sawcut 15' OC?

**Reply** – Follow Detail #4 on Sheet A1.1. As instructed in note #13 sheet A1.1 CONTRACTOR TO PROVIDE A PLAN OF PROPOSED LOCATIONS OF EXPANSION AND CONTROL JOINTS FOR APPROVAL PRIOR TO PLACING CONCRETE".

Question #17 - Note 4/A2.5 Calls out "exposed ceiling...- Paint all Exposed structure". Please clarify if the primary steel beams only to be painted or galvalume purlins also. Paint insulation? Will interior walls, specifically columns, require paint? Galvalume wall girts.

**Reply** – Paint only the primed steel structure. No need to paint the galvalume products and the scrim sheeting.

**Question #18** - Per title 24 ceiling R30 insulation is included. Will you require R19 insulation in the walls?

Reply - Wall insulation is not required.



**Question #3** - The Bioretention Facility shown on C-2 & WQMP-1 indicates masonry walls but calls out a spec for Caltrans Type B3-1A walls. This spec is for tapered cast-in-place concrete walls. Very expensive. Is this really what you want to use in this application? How about County Std Drawing 301a?

**Reply** - Replace the Caltrans retaining wall called for on the plans, Detail 2/C-2, with a SPPWC (Greenbook) Standard 610-3, H=6'. All other requirements shall remain as shown on Detail 2C-2.

Question #4 — The Bioretention Facility shown on C-2 & WQMP-1 calls for root barrier on the concrete walls. Is there a waterproofing system under this root barrier?

**Reply** - The root barrier is a waterproof membrane designed to prevent water infiltration.

**Question #5** - The Pump Station on WQMP-1 indicates that the effluent pipe extends to daylight. Is there an outflow structure or pop-up at the end of this effluent pipe?

**Reply** - Extend the 3-inch discharge line from the pump station to the flowline of the adjacent ditch. Question #11 - Specifications section 08 3323, 2.02, A2 states capable of withstanding 20 PSF wind loads. Spec section 13 3419, 1.5, C5a and b states building wind speed 120 MPH and wind exposure C. Will the 20 PSF door be sufficient or will a greater PSF be required?

Reply – The Overhead Coiling Doors shall be designed to withstand wind loads imposed upon the specific site where they are being installed. This may include a special wind study zone that applies to this project. Please omit specification Section 08 3323 2.02 A2 in its entirety. Revise "Design Wind Speed" from 107 MPH to 120 MPH in Specification Section 08 3323 1.05 DESIGN REQUIREMENTS A1.

**Question #12** - Specification section 13 3419, 2.1B states manufacturer substitutions can be found in section 01 6000 - PRODUCT REQUIREMENTS. Please provide this spec section.

**Reply** – That is a typo, see Specification Section 01 6000 PRODUCT REQUIREMENTS 1.06 SUBSTITUTIONS.

**Question #13** - Specification section 26 0010, 1.03A states CAD format must be submitted as record drawings. Please clarify, is this a requirement for electrical only or for the entire project.

**Reply** – The requirement is for electrical only but can be submitted on paper with neatly drafted red lines by hand.

Question #14 - There is a discrepancy as to POC for Domestic Water on two plans - WQMP 1 Plan shoes POC in the northern part of the site while C-1 shows the domestic POC on the south of the site. Please clarify which location to follow.

**Reply** - Follow the location shown on C-1 as this location avoids having to sawcut and patch the existing fire station driveway.
